We know, however, that Hawaii continued to permit the entry of foreign green beans that were fumigated on the mainland. Now it seems APHIS is permitting Puerto Rico to follow Hawaii's example (of violating a federal regulation?). The government of Puerto Rico has evidently not yet adopted a procedure by which USDA can bring green coffee beans into Puerto Rico. I request any and all documents regarding the APHIS change in Puerto Rico's green coffee import rules and the active role USDA is alleged to play in the transport of green beans to the storage facility in Puerto Rico.
